1. The **Senior Candidate Application** must be *must* be in the hands of the Region Senior Program Advisor **at least thirty (30) days prior to the Candidates first event/scheduled Test date** (as published in *DOWNHILL*). Notification of intent to participate in subsequent events a minimum of thirty days prior will ensure a sufficient number of evaluators are available for that event. There is **NO FEE** required for submitting this application, this information will allow for the appropriate program scheduling and staffing.
  2. This application, "**Senior Test Application**" and **Fee** *must* be in the hands of the Region Senior Program Advisor **at least two (2) weeks prior to the scheduled Test date** (as published in *DOWNHILL*). Separate applications are required for each Test, except as noted above. Applications without a Patrol Director's signature or the required fees will be rejected. If you have any questions, call the appropriate Region Administrator (i.e. OEC, Ski, Snowboard, Toboggan, etc.) or the Region Senior Program Advisor.
  3. The "**Senior Candidate Skills Sign-off form**" with the appropriate number of signatures (**two signatures for each skiing or snowboarding test and one signature for the toboggan test**) must be completed and notification of such must be submitted to the Region Senior Program Advisor **at least two (2) weeks prior to the scheduled Test**.
